

MUSICAL DIRECTOR PREVIEW TOUR JANUARY 2018

TOUR CONDITIONS

1. Cost

\$2500 per participant. To be eligible for the Directors' Preview Tour, non-refundable payment of \$2500 must accompany the Registration Form and be returned to Angas Travel no later than 31 July 2017.

This \$2500 will be returned to the school/payee when it commits to and pays its nomination deposit for a school tour to Europe booked with Angas Travel for 2019 or 2020, with a minimum of 30 students, prior to 30 June 2018.

2. Eligibility

- Eligible participants are limited to one per school/organisation, and must be the Music Director, Head of Performing Arts, Principal, or the nominee of one of these people.
- They should be from a school that has not previously travelled on an Angas Travel school tour.
- Maximum group size: 20. Applicants are accepted on a first come, first served basis.
- Participants agree to the following terms:
 - participate fully in the outlined itinerary for the entire duration
 - provide a detailed, written report upon completion for presentation to the school/organisation and Angas Travel
 - provide an article suitable for submission in their school/organisation's newsletter
 - share ideas and feedback with their fellow-travellers during the daily de-brief sessions
 - to receive their \$2500 back, they need to commit to a group tour to Europe with Angas Travel for no fewer than 30 students before 30 June 2018, for travel in 2019 or 2020.

3. Inclusions:

- Return economy class airfares with Emirates from nearest capital city to Vienna, and returning from either Paris or Rome.
- Airfare from Budapest to Venice (group A) or Budapest to Brussels (group B)
- Coach/rail transfers as per itinerary
- Accommodation (8 nights) – single room
- Breakfast and dinner each day, and one lunch in Vienna.
- All organised sightseeing activities as listed in the itinerary.
- Bi-lingual tour escort
- Experienced Australian Music Educators as tour leaders:
 - Group A will be escorted by David Mowat, Assistant Head of Music, Wesley College St Kilda Road Campus, Melbourne, VIC.
 - Group B will be escorted by Roger Hey, Director of Music, Perth Modern School, WA.
- Recognition of Professional Development (see point 9 below)

4. Exclusions:

- Passport and Visa Costs
- Meals other than those mentioned above.
- Travel Insurance.
- Sightseeing and entrances other than those mentioned.
- Any costs involved in deviations from the group travel itinerary should an applicant wish to make extra/alternative arrangements (see point 8 below)

5. Passports & Visas

Passports must be valid for at least 6 months after travel is completed. Holders of Australian and EEC countries' passports do not require a visa for travel to Austria, Hungary, Italy, Belgium or France. For other passport holders Angas Travel will assist members of the tour in obtaining visas, if required. Please advise Angas Travel if you have a passport of different nationality.

6. Insurance

All tour members are responsible for arranging their own travel insurance. As an agent for QBE Travel Insurance, Angas Travel is able to provide a quotation for Travel Insurance if required. Please contact us for a quote.

7. Payment

As above, payment of \$2500 must accompany the Registration Form and be returned to Angas Travel no later than **31 July 2017**.

8. Independent Travel

- i) It is a requirement of the group airfare that all tour members travel together on the same flight from Dubai to Vienna, and on the same return flights from Europe to Australia, as per the itinerary.
- ii) If you should wish to depart or return independently of the group, this may be arranged subject to the airline's group airfare conditions. Please be aware that extra costs will be incurred.
- iii) There is a strict limit to the number of passengers who can deviate from a group booking and, again, this will be on a first come, first served basis.
- iv) All tour members must participate fully in the outlined itinerary for the full duration.
