TOUR CONDITIONS

1. General

The purpose of these Tour Conditions is to inform all concerned, as precisely as possible, the total costs associated with the tour and the general conditions.

2. Tour Cost Inclusions

The tour cost is inclusive of:

- All ground transportation - by private, deluxe air-conditioned coaches, including all costs for the driver
- All accommodation - 4 star - in twin or double rooms. Single room with supplement. Including daily buffet breakfast
- All meals as specified
- English speaking Tour Manager experienced in music tour management throughout the entire tour
- Guided sightseeing tour by a professional licensed English-speaking local guide in Bonn, Prague and Vienna
- All entrance fees as per itinerary
- Concert attendances and Beethoven lectures -
 - 4 x Quality Beethoven related concerts in Bonn, Prague, Vienna, Salzburg
 - 4 x Music Talks about Beethoven's life and music by David Slater
 - 3 x Music Talks by a professional (details to be determined)
- All local taxes and gratuities.

3. Exclusions

The tour cost does not include:

- Passport and visa costs (holders of Australian and EEC countries' passports do not require visas)
- Items of a personal nature
- All optionals (extensions to Passau and Regensburg)
- Personal travel insurance. See note 6 below.

4. Exchange Variations etc.

Subject to exchange rates remaining stable, the actual tour cost is based on:

Australian \$1 = Euro 0.58 (it will be adjusted at the time of final payment)

5. Passports

Tour members are responsible for arranging their own passports and visas if required. Angas Travel will assist in any way possible in this regard. Visas are not required for Australian passport holders for a journey of this duration to Europe.

ETIAS ([European Travel Information and Authorisation System](#)) for Europe is set to launch in the **last quarter (Q4) of 2026**, following the phased rollout of the Entry/Exit System (EES) in late 2025, with a six-month transition period before it becomes mandatory for visa-exempt travelers. No action is needed from travelers yet, but you'll need an ETIAS authorization for short trips to Schengen countries after this period. Angas Travel will monitor the situation and provide updated information as it becomes available.

6. Insurance

Travel insurance is compulsory for all tour members. Please contact our consultants for a quote.

7. Payment Schedule

Payment for the tour is to be sent to Angas Travel and will be required as under:

Deposit		20 % deposit of total tour cost on or before 31 July 2026 (non-refundable)
1 st Instalment		40 % of total tour cost due on or before 06 November 2026
Balance		due on or before 05 February 2027

11. Cancellation Policy

Date of cancellation	Cancellation fee
Deposit	Non-refundable
Cancellation on or after 06 November and before 05 February	50% of total tour cost
Cancellation on or after 05 February 2027	100% of total tour cost

* Please note that most concert tickets are non-refundable in the event of cancellation.

Depending on the reason for your cancellation, these charges may be recoverable under the insurance cover.
